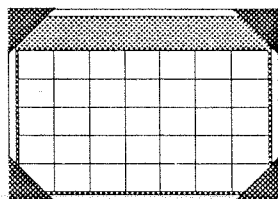
EDITORIAL STATEMENT

DOCTORAL PRACTICUM AT NAL

The National Agricultural Library, like NLM, is a pioneer in applying computer technology to enhance library services and products. During October and November, 1990, Jo Ann Tibbs was the first librarian to serve a doctoral practicum (internship) at the NAL in Beltsville, MD. She participated in an experimental computer screen design for a multimedia CD-ROM currently under development by NAL. This CD-ROM, on the topic of plants used for ornamental horticulture, will contain text, graphics, and sound. The National Agricultural Library (NAL) is one of the largest agricultural libraries in the world and in one of the three national libraries in the United States (the Library of Congress and the National Library of Medicine are the other two). While NAL's primary function is to support the mission of the U. S. Department of Agriculture, the library also provides researchers, other libraries, and the general public with specialized information in the fields of agriculture and related sciences.

AIDS CARE AND SERVICE PROVIDERS - a database of individuals, institutions, organizations, and research activities on AIDS in the tri-county area produced by the Library

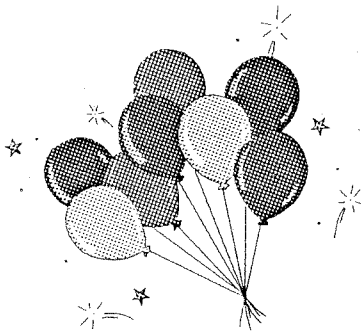
CALLCAT - the database and document request components for ready, free, and remote access to the Library's rich resources on AIDS and AIDS-related diseases.

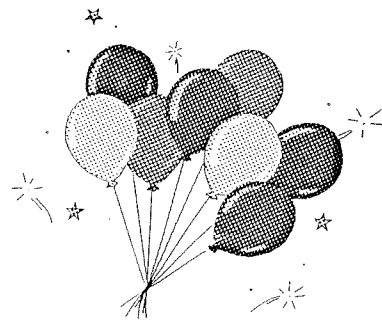
MULTI-LIBRARY GROUP IN JACKSONVILLE

1991 SOUTHERN CHAPTER MEETING



It's time to start making plans to participate in the Southern Chapter's annual meeting, October 18-21, 1991 in Jackson, Mississippi. Ada Seltzer, 1991 Convention Chair; Chris Jones, Program Chair and Vice-Chair/Chair Elect; and David Jeurgens, Chair of the SC/MLA Professional Development Committee have literally set new standards for the annual get-together.

The meeting's theme, Leadership: Values and Visions, is epitomized by the four invited speakers and topics. Bill Ferris, Director of the Center for Study of Southern Cultures, will deliver the keynote address - "Memory and Sense of Place in the South: Health Practices and their Cultural Expression." On Friday, October 18, CE 683 Research Methods for the Health Sciences will be taught by Dr. Joanne Marshall; CE 003 Oncology" Concept and Resources will be taught by Martha Watkins; and the Library Manager as Leader, the first of two courses by Guy St. Clair, President of SLA, will be offered.

On Monday October 21, a new version of the very popular NLM Update course will be offered. NLM Back to the Fundamentals: a Review and Update of the ELHILL System with Emphasis on Recent Changes in Searching MEDLARS will be taught by Roberta Bronson of the Eastern Regional Online Training and Information Center. Back by popular demand is CE 312 Development and Assessment of Health Sciences Library Collections taught by Daniel Richards. Evaluating and Justifying the Library is the second course that will be taught by Guy St. Clair for our members. The Professional Development Committee expects a record attendance so be sure and register early.

The Local Arrangements Committees have organized what can best be described as a happening. "Exploring Mississippi's Past: a Touch of Elegance" is the theme of the welcome reception at the beautiful Fairview House. The Annual Meeting of the Florida Health Sciences Library Association (FHSLA) was called to order by the President, Thomas Williams, at 12:45 p.m. Tom welcomed all members present.

Gwen Walters moved that 1990 Annual Meeting minutes be accepted as distributed and published in the ALERT. Seconded by Janie Jones. The motion was passed.

FHSLA officers and committee chairs were introduced and thanked for all of their work during the year.

PRESIDENT'S REPORT

Tom Williams reported that seven persons had taken advantage of the scholarships afforded by FHSLA to attend the annual meeting. Approximately \$1,000.00 was spent for scholarships. FHSLA may want to plan for future decisions concerning who should receive the scholarships. At the present time, there are not enough applicants to warrant having a policy.

FHSLA contributed \$200.00 to co-sponsor a coffee break at the Southern Chapter meeting in Atlanta, Georgia. The association also voted to contribute \$500.00 to the endowment for the Cunningham International Scholarship.

Special thanks were extended to Naomi Eli and the Strategic Planning Committee for their hard work during the past year. Linda Kressal also received thanks for her work to secure our tax exempt status. Patricia Buchan was appointed Union List Coordinator. Thanks to Jenny Garcia and Ms. Dix for the publication of the ALERT.

Tom expressed his enjoyment of serving as President.

COMMITTEE REPORTS

TREASURER:

Linda Kressal, treasurer, thanked the Jacksonville group for the fine accommodations and all the planning that had gone into this years meeting.

Tax exempt status was received from the IRS under code 501A after the revisions of our by-laws in 1990. We are exempt from having our income taxed. The IRS wants us to pay fines for not filing for 1984 to date. Organizations with income less the \$25,000.00 do not have to pay income tax, but must file a tax report. Our mistake was a failure to file a tax report. If we should have to pay the fines it will amount to about \$300.00. We are currently seeking legal advice on this matter.

The balance as of December 31, 1989 was \$8,531.61. The balance as of December 31, 1990 was \$9,145.10. See the Treasurer's Report January-December, 1990 for details of the transactions.

NEWSLETTER:

Jenny Garcia, the editor of the ALERT reported that she had spent \$375.00 for the publication of the ALERT and the Membership Directory.

ARCHIVES:

Van Afes, reported that the archives are growing and requested that all committees send copies of their minutes to him. Back editions of the Directory and programs from the various meetings are still needed.

Naomi Eli was happy to announce that the Strategic Planning Committee was functioning this year.

She reported that plans were still on going to implement a Policy and Procedure Manual for FHSLA and to Continue the study Current Status of Hospital Library Funding. Jo Ann Tibbs is the chief investigator for the latter project.

Janie Jones moved that the Chair of the Membership Committee will appoint the editor for the Membership Directory. Seconded by Gwen Walters.

Discussion: Tom Williams explained that it is necessary for the editor of the membership directory to have the appropriate software and if they do not, then they are free to appoint someone that does.

Motion carried.

Janie Jones moved that the Program Committee have a CE Coordinator appointed by the President for a two year term. Seconded by Gwen Walters.

Discussion: It was explained that the CD Coordinator would be responsible for surveying the membership for desired educational opportunities and to sponsor or develop continuing education opportunities for target membership groups.

Motion carried.

MEMBERSHIP:

Janie Jones reported that there were currently 96 paid memberships. She also thanked Calder Library for volunteering to do the Membership Directory for this year. Seventy-five persons were registered for the meeting. A total of 33 persons were enrolled in the CD classes.

PROGRAM COMMITTEE:

Pam Neumann recognized all the people that had served on the program committee and thanked them for their hard work.

Janie Jones recognized and thanked all of those that had served on the local arrangements committee.

NOMINATING COMMITTEE:

Pam Neumann reported that there was only one officer to be elected this year, the President-Elect. The nominating committee nominated Nell Wooley for the position. Tom Williams asked if there were any nominations from the floor. There being none, Nell Wooley was elected by acclamation.

OLD BUSINESS:

NEW BUSINESS:

Jean Shipman was introduced as the RML representative.

Nell Wooley and Pat Cole provided information concerning the 1992 meeting which will be held in Orlando, Florida. It is to be a joint meeting with the Southeastern Conference of Hospital Librarians.

Pat Cole and Nell Wooley then extended the invitation to come to FHSLA in Orlando by singing Orlando, Orlando, in 1992.

Tom Williams recognized all of the work that the Jacksonville people had done for us to have such an enjoyable meeting. Pam Neumann took over as the new President.

STRATEGIC PLAN

1991-1992

MISSION STATEMENT

The mission of the Florida Health Sciences Library Association (hereafter, the Association) is to promote and advance access to information resources and services in support of quality health care in Florida.

GOALS

To achieve its missions, the Association has six goals:

1. Promote access to health sciences information in Florida through the biomedical library network.
2. Provide support for changing roles, needs and concerns of its members.
3. Support professional standards for health sciences libraries in Florida.
4. Increase membership in the Association.
5. Improve information network development in Florida.
6. Improve cooperative relationships with other information and health care organizations in Florida and surrounding states.

The Strategic Planning and Executive Committees have identified five areas of emphasis to achieve the Association's goals. This plan formulates objectives for 1991/92.

I. Membership

- A. Goal: Increase the Association membership by 5% by the end of 1991-92 and, thereafter, retain the membership and annually reassess growth potential.
- B. Objectives:
 1. Expand recruiting for membership to include junior colleges and allied health programs, public libraries with consumer health programs, non-professional library managers, and newly appointed librarians in the State. Add them to the Association mailing list and make appropriate further contacts.
 2. Include dues notice and committee appointment volunteer form in newsletters.
 3. Contact a) individuals and institutions who previously were members of the Association; b) Florida members of associations such as MLA, SC/MLA, etc.
 4. Compile, publish, and disseminate an annual Association Membership Directory.

C. Implementation:

The Membership Committee is responsible for accomplishing objectives 1–3. The Membership Committee and the newsletter editor are jointly responsible for accomplishing objective 2. **The Membership Chair or appointee will serve as Membership Editor and is responsible for accomplishing objective 4.**

II. PROGRAMMING

A. Goal: Provide support for the changing roles of the membership through the Association's activities.

B. Objectives:

1. Include developments in information management (such as new technologies and roles, marketing strategies, interconsortia communication) as topics for the Association's annual meetings and the newsletter.
2. Survey the membership for desired education opportunities.
3. **Provide clearinghouse coordination of courses and qualified instructors within Florida and publicize activities through the newsletter.**
4. Sponsor and/or develop continuing education opportunities for target membership groups, such as beginning managers, experienced managers etc.

C. Implementation:

The Program Committee and the newsletter editor are jointly responsible for accomplishing objective 1. the Program Committee and the CE Coordinator are responsible for accomplishing objectives 2 and 4. The CE Coordinator and Newsletter Editor are responsible for accomplishing objective 3.

III. COOPERATIVE RELATIONSHIPS

A. Goal: Develop cooperative relationships with other information and health care organizations.

B. Objectives:

1. Continue coordinating with other organizations (e.g., FHA, SLA, and FLA) and contact them regarding possible mutually beneficial activities.
2. Continue to encourage existing relationships (e.g., the State Library) by inviting representatives to the Association meetings.
3. Continue contact with SE/A RMLS staff in areas of mutual interest.

C. Implementation

The Executive Committee is responsible for accomplishing objectives 1–3.

IV. NETWORKING

A. Goal: Improve information network development in Florida.

B. Objectives:

1. Continue to support consortia.
2. Continue to encourage the use of DOCLINE. Support a uniform electronic mail service (currently DOCLINE).
3. Encourage and facilitate participation in Southeastern/Atlantic Regional Medical Library Services regional holdings lists.
4. Encourage the development of state wide networks and continue to inform the members about services such as OCLC, FCLA (LUIS), and others.
5. Encourage telefacsimile networking.

C. Implementation:

The State Union List Coordinator is responsible for accomplishing objective 3. The Strategic Planning Committee is responsible for accomplishing objectives 1, 2, 4, and 5.

V. AD HOC COMMITTEES (FOR THESE SPECIFIC PURPOSES)

A. Goal: Establishment of Ad Hoc Committees to fulfill the needs of the following objectives.

B. Objectives:

1. Production of a policy and procedures manual for FHSLA to be handed down to incoming officers and chairmen of committees to assist them in the execution of their duties.
2. Study to be conducted on the "Current Status of Library Funding and Staffing," so that FHSLA members and other interested parties may better understand and perhaps solve some of the problems facing health sciences libraries today.

C. Implementation:

The Executive Committee and the Chairperson of each committee is responsible for accomplishing objective 1. The Principle Investigator of the study, the library school Consultant and the Advisory Board for the study are responsible for accomplishing objective number 2.
