## PRESIDENT'S PAGE

As 1993 comes to a close, Florida health science librarians should look back on this year as a dynamic one! If variety and change energize you professionally, then this past year was probably one of your favorites.

Obvious changes will occur as part of the national mandate for health care reform and the recently unveiled "Health Care Reform Act." The impact on medical libraries will become more apparent as time goes on. But for more tangible changes, first, take a look at the newly published Joint Commission Accreditation Manual for Hospitals. Although library services aren't represented as well as we had hoped, the move to include "management of Information" as a key component in the integration of services in a hospital is a step in the right direction.

Next, check out the final draft of the MLA Standards for Library and Information Services in Healthcare Institutions (published in the November 1993 issue of National Network). These standards are due to be approved in February of 1994 and represent the first revision of our professional standards by MLA in over 10 years. In the preface, the authors admit that "the need to revise this document developed as a response to the changes occurring in hospital libraries with the proliferation of microcomputers and access to advanced information technologies."

And, are you aware that the National Library of Medicine has created a new "National Information Center on Health Services Research and Health Care Technology"? Research in health services will be gaining a bigger spotlight as the 1990's progress and the development of this Center with a budget of \$8 million for FY 1994 speaks to the importance of the role of research in our profession.

There's nothing like reviving the past and making it new again to capture our attention. That's just what happened on Friday, January 21, 1994, when NLM broadcast the Annual MEDLARS Update via satellite. The two-to-three hour transmission focused on MeSH changes, system/database changes, and other online topics. This broadcast replaces the Updates that formerly were presented at regional or local meetings in the mid-1980's. If you don't have satellite-receiving capabilities and would like to borrow a copy of the broadcast, contact the NN/LM SE/A Regional Staff (800/338-7657).

Finally, let's not forget about "people" changes! With Ted Srygley retiring as Director of the University of Florida's Health Sciences Libraries, FHSLA says farewell to a professional who signifies excellence in librarianship. We wish Ted many years of good fishing and look forward to his attendance at future FHSLA annual meetings as an esteemed Honorary Member!

Happy New Year! May 1994 continue the momentum of change and be dynamic and enlightening for all of us!
