ANNUAL BUSINESS MEETING MINUTES
JACKSONVILLE, FLORIDA
APRIL 24, 1998**

The annual business meeting of the Florida Health Sciences Library Association was called to order at 9:00 A.M. by the president, Marta Cosculluela. She introduced the officers: Barbara Francis, Vice President and Program Chair, Prudence Tucker, Treasurer, and Dorothy Kelly, Acting Secretary, for Mary Kaye Raddatz. She also introduced the committee chairs: Linda Butson, Alert Editor, Jenny Garcia-Barcena, Archivist, Susan McCullough, CE Coordinator, Addajane Wallace, Membership Chair, Barbara Francis, Nominating Chair, Bettye Stilley, Strategic Planning Chair, Jan Booker, Union List Coordinator, Prudence Tucker, List Serv Coordinator, and Pat Cole, Immediate Past President.

PRESIDENT'S REPORT:

Marta expressed that we had a very productive year, and acknowledged the diligent efforts of Barbara Frances and her team members in planning the joint Annual Meeting. The Strategic Planning Committee chaired by Bettye Stilley, the Executive Committee and subcommittees have been working on several projects.

SECRETARY'S REPORT:

The minutes of the 1997 meeting were reviewed and approved as written. Our secretary, Mary Kaye had her surgery and we were happy to report her condition was stable.

TREASURER'S REPORT

Prudence Tucker reported that as of 12/3/96, there was a balance of \$6,746.26. Income during 1997, including dues, meeting income, and donations, totaled \$15,065.00. Expenses were \$12, 581.71, leaving a balance of \$9,229.55 as of 12/31/97.

ALERT EDITOR'S REPORT

Linda Butson, Editor, reported that two publications will be mailed by the end of July. One hundred fifty-eight (158) brochures were distributed with the Spring issue in January, 1998. Linda thanked everyone for their articles and asked that they continue sending them in.

UNION LIST COORDINATOR'S REPORT

Jan Booker reported sending out three (3) packets for DOCLINE participation along with letters of welcome and FHSLA membership forms.

COMMITTEE REPORTS:

STRATEGIC PLANNING COMMITTEE chaired by Bettye Stilley, reported the committee met November 14, 1997, in Orlando. Bettye contacted RML concerning library exhibits at state health professional association meetings. A membership brochure was developed by John Orriola and distributed at the annual meeting. The Strategic Plan has been updated, and placed on the Web Page by Judy Johnston.

EXTERNAL PARTNERSHIP SUBCOMMITTEE

under chairperson, Midge Wallace is working on emphasizing our contribution to the public. The SPC is pursuing projects for Medical Library Month in October. We need to be looking at the ads in county medical bulletins or contact Pat Clark regarding advertisements for exhibiting at association meetings in your own town. Grants are also available.

The **LISTSERV SUBCOMMITTEE** chaired by, Prudence Tucker, now has sixty four (64) members in service. Anyone wanting to join can contact the ListServ owner to sign up. (**Editor's note:** The LISTSERV ownership has changed see article on p.2.)

MEMBERSHIP COMMITTEE chair, Midge Wallace, reported we presently have one hundred and eight (108) members.

PROGRAM COMMITTEE chair, Barbara Francis reported ninety nine (99) registrants from both states, fifty-five (55) from Florida, thirty-three (33) from Georgia and eleven (11) other. Shared expenses: our costs for scholarship, executive lunch, and preliminary \$1200. Preliminary figures are; total joint expenses of \$12,000, income of \$13,000 and profit of \$1,000.

CONTINUING EDUCATION COMMITTEE chair, Susan McCullough reported setting up three CE classes for this year's program. Total enrollment of fifty-nine (59).

**Grass Roots: The History of the Florida
Health Sciences Library Association**

FHSLA began its "grass roots" existence at the Regional Conference of Florida Medical Librarians (RCFML) on April 19, 1961. This first meeting was held in the VA Medical Center in Bay Pines at the invitation of its Chief Librarian, Florence Bulmer. Other medical librarians attending this historic first meeting were: Eleanor P. Diekema, Helen Donnelly, Christine Metcalf, Stephania Osborn, Pauline Woolridge, and Mildred Moore. After drawing names out of a hat, Stephania Osborn was "selected" president.

Membership categories included active, associate and honorary. The first honorary member was Fred Bryant, then Director of the J. Hillis Miller Health Center Library, University of Florida. His early support for this group was championed by his successors, Mayo Drake and Ted Syrgley. Annual dues were \$2 for active members, \$1 for associate members, and nothing for honorary members. Active members were professional librarians, while associate members were paraprofessionals. Later in 1964, the associate category was eliminated and only one level of active membership was established.

Initially, meetings were held four times a year to increase training and learning opportunities. The name was changed to Florida Medical Librarians in 1967 and the meetings were reduced to three times a year. In 1970 the

number of meetings was reduced to two per year, and in 1979, one annual meeting was established with a more formal program and a CE class/workshop format. In 1982, the name of the organization changed a third time to the Florida Health Sciences Library Association to support a broadening of its membership base and focus.

In keeping with its early direction towards resource sharing, the group supported regional union list activities, consortia development, and participation in regional medical library programs such as the Hospital Library Consultants Registry, and a planning process for state-wide delivery of medical library services and professional development for its members in the 1980's. *FHSLA Alert*, the official newsletter, was first established in 1984. Its editorial and distribution responsibilities have rotated between the three medical school libraries in the state. Annual meetings have rotated between these three regions for variety, and are supported by the medical school librarians and hospital library staff in the areas, including outstanding meetings in Palm Beach and Disneyworld.
