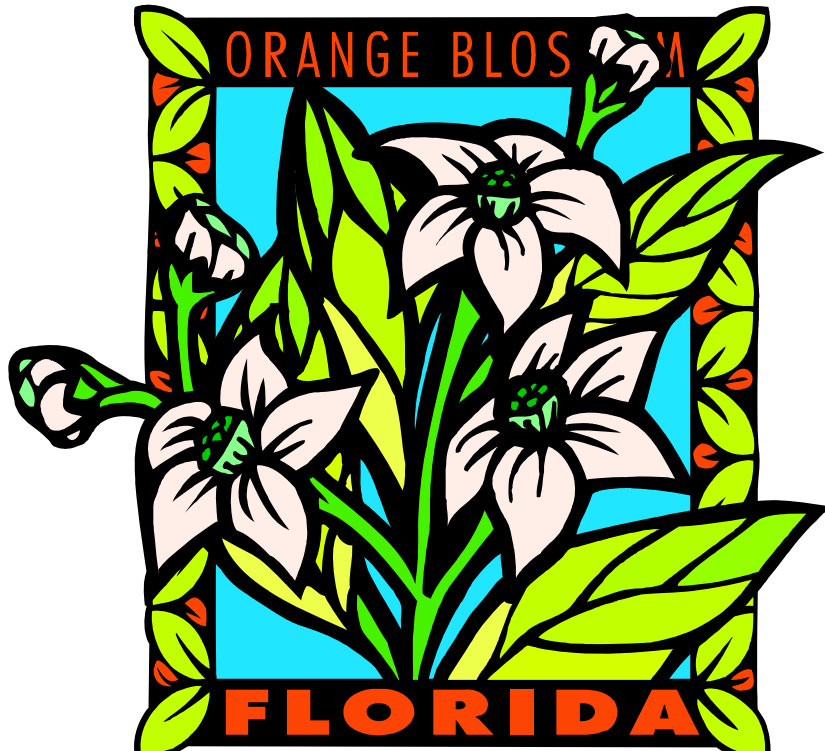

## Strategic Planning Committee Phone Survey

In October and November 2007, members of the Strategic Planning Committee undertook a phone survey of dues-paying members to solicit input on a number of issues related to FHSLA. Thank you to those who contributed and gave us your input. We apologize if we missed you! Some people were on vacation, out of the office or otherwise unavailable when we called. If you were not contacted and have input you'd like to share, please contact Allison Howard at [ahoward2@healthlib.usf.edu](mailto:ahoward2@healthlib.usf.edu) or 813-974-4752.

Here is a summary of the questions and responses.

### Why belong to FHSLA? How is it Important?

A total of 67 people (74% of membership) were interviewed and almost all indicated that they belong to FHSLA for the networking opportunities; to learn from colleagues; and to participate in CE classes and professional development workshops. A number of people stated they felt it was important to be involved in the state professional organization.

### Joint Meetings?

58 or 87% of people liked the idea of having joint meetings with other groups as it could broaden the scope of classes and speakers we'd be able to obtain by sharing the costs with another organization, and they'd be able to attend 2 conferences at once. The predominant groups suggested were: Georgia, Alabama, Mississippi, Louisiana Health Sciences Library Associations, Florida Library Association, Florida and Caribbean chapter of Special Libraries Association, Tampa Bay Medical Library Network (TaBaMLN), and the Miami Health Sciences Library Consortium.



Other suggested organizations included: SC/MLA, Florida Association of Community Colleges, Southeastern Florida Library Information Network (SEFLIN), Tampa Bay Library Consortium (TBLC), Central Florida Library Association (CFLA), North Florida Library Association (NFLA), Florida Association of Educational Communications and Technology, JACHO, Groups within universities, CMEs for nurses, physicians, residents, Consumer Health Groups, Florida ACRL, Nursing or Medical Associations, Florida Hospital Association, EBM Joint Meetings, Mental Health Libraries, and NIH.

At the same time, people wanted the joint meetings to be held in Florida and wanted FHSLA to keep its niche as a regional group. Several people spoke of enjoying FHSLA's warm intimate nature and the ability to truly get to know one another without getting lost in the crowd and didn't want to lose that aspect.

### Phone Survey (cont'd.)

Also raised was the concern that planning a joint meeting requires not only a lot of lead time, but is much more difficult and time consuming to coordinate and plan. It's been done in the past with different groups with varying results.

### Additional Continuing Education Opportunities During the Year?

On the question on whether people were interested in having CEs during the year and not just at the annual meeting - 57 (86%) responded yes, on the condition that the CEs were relevant, practical and local (their geographical area!). Full day or half day preferences were dependent on the topic and the distance needed to travel. Four (6%) people felt that CEs during the year would detract from the annual meeting.

### Virtual Meeting Every Other Year; One Day Meeting?

Two questions were added halfway through the survey and were addressed by 49% of the people called. These questions were extensions of a discussion held at the annual meeting about 1) whether we should alternate a physical meeting with a virtual meeting and 2) whether FHSLA should consider a one day meeting with CEs throughout the year. 77% wanted a meeting every year and felt that the face-to-face meeting was important, further emphasizing the desire for time to network; 23% said a physical meeting every other year would be fine as there were other groups to network with, although several had reservations on whether FHSLA would remain viable. Of those who answered the question about having a one-day meeting, 52% said no, mentioning the meeting wouldn't be as information packed and people might be less motivated to attend given the size of Florida and the distance needed to travel; 48% really liked the idea. Looks like we'll need to do some more thinking about this one!

### Other Individuals Interested in FHSLA?

Your colleagues made a number of suggestions of people who might be interested in joining FHSLA. These names and their contact information were forwarded to the Membership Committee.

## Florida Consumer Health Information Network (FCHIN) Update

The Florida Consumer Health Information Network continues its work to explore the goals set out in the NN/LM planning award:

- Increase Florida residents' knowledge of consumer health information resources and services available statewide and from local communities;
- Establish an organizational structure for coordinating and planning for improved access to consumer health information resources and services;
- Partner with existing agencies, organizations and libraries in order to improve access to existing consumer health information resources and services available from local communities;
- Identify and organize consumer health information resources and services available statewide;
- Create a website that meets the consumer health information needs of Florida residents;
- Coordinate and strengthen a network of librarians, healthcare providers and organizations in Florida to increase knowledge, skills and awareness of quality consumer health information resources; and
- Identify funding resources from a variety of federal, state, local and private sources to carry out the plans of the steering committee.

Of special note at this time is our partnership with the Florida Agency for Health Care Administration and its advisory council on consumer health information (State Consumer Health Information and Policy Advisory Council). AHCA unveiled a new consumer health portal, FloridaHealthFinder.gov, in November 2007. At the December 4 meeting of the Advisory Council, Mark Flynn was asked to speak about currently available consumer health information resources licensed by the Florida Electronic Library and Barbara Shearer was asked to talk about the FCHIN. The presentations were well-received by the Council and the following was reported in the draft minutes currently posted to the Council's meeting website:

**Presentation: Florida Electronic Library** – Karen van Caulil introduced Mark Flynn, Library Program Administrator for the State Library and Archives of Florida, and Ms. Barbara Shearer, Director of the Charlotte Edwards Maguire Medical Library, College of Medicine at Florida State University. Mr. Flynn provided the members with a presentation on the Florida Health Information Network and the Florida Electronic Library and recent efforts to provide health information, along with a variety of other information, to Florida's citizens through the use of the statewide library network. Ms. Shearer provided an overview of the long range plan of the steering committee which includes focusing on outreach and other coordination of information for public and professional use. It was explained that it is the desire of the Florida Electronic Library to pursue avenues of collaboration with the Advisory Council to provide better information to citizens who are seeking answers to health questions beyond a simple definition.

### FCHIN Update (Cont'd)

Mr. Flynn explained that the initiative began when trying to empower librarians to be able to provide information that was vetted, accurate and up to date. An infrastructure was put into place that allowed any user to access through any public library in the state simply by entering their library card information. Ms. Shearer stated that the committee would review the Council's current strategic plan to determine if there were areas where the two groups could collaborate. She informed the members that it is the steering committee's feeling that there could be a way to offer the medical information, articles and research that are available through the FEL by developing seamless coordination of information for both the public and the medical professional. Secretary Agwunobi thanked both Mr. Flynn and Ms. Shearer for the informative presentation and vowed to commit the Agency to working with them to explore possible levels of collaboration as quickly as possible.

AHCA TASK: Work with Florida Electronic Library and its steering committee to determine possible avenues of collaboration for the expansion and enhancement of the current website as quickly as possible.

On December 10, at the face-to-face meeting of the FCHIN steering committee held in Orlando, the FCHIN welcomed Dr. Karen L. van Caulil, Chair of the Public Relations Workgroup charged with marketing and training for FloridaHealthFinder.gov, for a discussion of ways the Advisory Council and its workgroups could collaborate with FCHIN. Action items from this December 10 meeting included sending names of FCHIN steering committee volunteers interested in working on both the Public Relations Workgroup and the Web-site Workgroup to Beth Eastman, Interim Bureau Chief, Florida Center for Health Information and Policy. As a result, Kaye Robertson and Pat Clark were asked to serve on the Public Relations Workgroup and Mark Flynn was asked to serve on the Web-site workgroup, and several interested parties were selected. To clarify, interested parties may serve as proxies for the Workgroup members and are included in an e-mail distribution list so they are kept abreast of workgroup activities. FCHIN members on the interested parties list are Bev Shattuck, Nancy Teger, Allison Howard and Barbara Shearer.

At the request of Beth Eastman, FCHIN was asked to present at the January 29, 2008, Public Relations Workgroup meeting. Barbara Shearer made the presentation and Debra Flemming, Web Manager for the State Library and Archives, assisted in answering questions about the Florida Electronic Library. Several action items resulted from the Workgroup meeting specific to marketing and training users to access the FloridaHealthFinder.gov website. There is great interest by AHCA in working with the Florida Electronic Library, the public library community and FCHIN to develop and deliver both marketing and training to Florida citizens. This is just the beginning of a new partnership between AHCA and the library community in Florida. We will provide updates as work progresses. ### Additional Suggestions

## State / National / International Activities

**Linda Butson** and **Beth Layton** were named to the newly formed Florida Health Information Network Steering Committee. Linda, representing UF's AHEC program, and Beth, Acting Director of the HSC Libraries, are serving on the Steering Committee for the Florida Consumer Health Information Network. This committee, chaired by Barbara Shearer from Florida State University, is focused on efforts to improve access to consumer health information for Florida residents.

**Lenny Rhine**, HSC University Librarian Emeritus and former head of Collection Development, is coordinator of the 2007 Librarians Without Borders/Medical Library Association *e-library training initiative* funded by publishing giant Elsevier. Through this initiative, he is working with the HINARI project – a World Health Organization-facilitated program that, together with major publishers, enables developing countries to gain access the world's largest collections of full-text biomedical and health e-journals. Besides updating and developing new training materials, Lenny has conducted workshops in Vietnam, Nigeria, Nepal, Zanzibar, Tanzania and Cambodia. In July 2007, he was awarded Fulbright Senior Specialist status and is eligible for a two- to six-week grant through this program.

**Michele R. Tennant**, Bioinformatics Librarian, has returned from a yearlong sabbatical, during which she conducted research projects for two fellowships she was awarded in 2007: the Medical Library Association's Kronick Travelling Fellowship and the Lindberg Research Fellowship, testing biological and biomedical researchers and students to see how well (and by what methods) they use bioinformatics resources from the National Center for Biotechnology Information. From July through November, she performed her Kronick and/or Lindberg research at, variously, the following institutions: the University of Southern California-Norris Medical campus, Harvard's Countway Medical Library and the Ernst Mayr Library of the Museum of Comparative Zoology, the University of Arizona's Science and Engineering Library and Health Sciences Library in Tucson, the University of Southern California's Seaver Science and Engineering Library and UCLA's Louise Darling Biomedical Library.

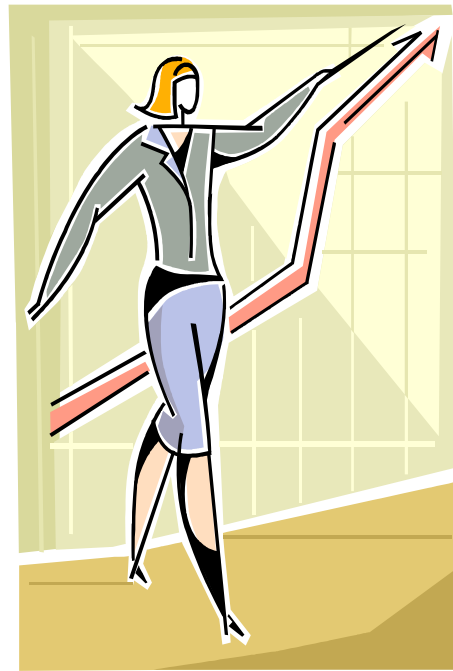
### Papers, Presentations, Publications and Teaching
