The FHSLA Business Meeting was called to order by President Nadine Dexter at the Renaissance Vinoy Resort and Golf Club, St. Petersburg, FL on Friday, May 30th, 2008 at 11:20 AM

Plenary Speakers Summary

Allen Byington, Director of the Big Bend Regional Healthcare Information Organization (Big Bend RHIO), defined what a RHIO is, as shown through his organization. A RHIO or RHIN (Regional Health Information Network) consists of a web portal that presents a unified view of medical information with a single sign-in. The Big Ben RHIO contains information about prescriptions and medications, patient intake forms, and a personal health record. It is a transition from faxing to scanning information and was produced through collaboration with American Health Care Association (AHCA). It is based on a broadband system producing a fiberoptic medical network. Used initially to transmit radiology studies, this RHIO has proved its sustainability as a central repository. The Personal Health Record for the patient to fill out also allows the option not to participate in this portion. This dedicated broadband network connects rural areas for exchange of health information.

Stephanie Blay, Project Manager of the Tampa Bay RHIO, spoke less about the technical side of RHIOs and emphasized the “Change Model” that this RHIO used. Resistance to change is hard to overcome, but change equals creativity in problem solving. The biggest challenge has been to get folks to see the value of change and of the RHIO. She quoted Darwin by saying that survival of the species is not by “...the strongest species or the most intelligent but by those most responsive to change.” The Tampa Bay RHIO built the technology needed, and the demonstration stage was successful. The primary mission was to foster adoption of an information exchange and to use collaboration with all the participants to accomplish this. Change masters are needed in many different fields. The RHIO has information for providers, employers, consumers, payers, and government, and studies opportunities and fears for each category.

Florida Consumer Health Information Network (FCHIN) Update - October 2008

Background

The Florida Consumer Health Information Network (FCHIN) begins its second year as a network of librarians exploring ways to effectively and efficiently deliver consumer health information to Florida residents. Throughout its first year, FCHIN held four face-to-face meetings and five teleconference meetings to:

- 1) Identify common interests and opportunities for collaboration with each other and with Florida state agencies and
- 2) Set priorities for providing Florida residents with greater access to quality consumer health information resources.

May 2008 Organizational Meeting

In May 2008, the FCHIN steering committee met for an organizational

meeting at the FHSLA Annual Meeting held in St. Petersburg. Linda Butson led a discussion on next steps asking each member to identify three priorities or goals for FCHIN. The following are the responses receiving the most votes and grouped into broad categories:

- Develop & carry out a training agenda in consumer health information for public librarians (11 votes)
- Identify partners, specifically AHCA (6 votes)
- Develop an FCHIN website or portal and include Florida specific resources (5 votes)
- Investigate GoLocal and perhaps develop new model (3 votes)
- Continue to grow our steering committee and become more efficient such as forming more

structure with committees (3 votes)

- Continue to meet face-to-face (2 votes)

As a result of these discussions, the FCHIN Steering Committee created 3 subcommittees: the Communications/Marketing Subcommittee to communicate about FCHIN efforts and Florida consumer health information resources; the Education and Training Subcommittee to explore ways to deliver and coordinate education and training to librarians and others; and the Content Subcommittee to study and plan the most effective way to deliver current and new consumer health information content to Florida residents including exploration of a Gale GoLocal tab in the Florida Electronic Library.

Subcommittee Members, including FSHLA member volunteers, are:

- 1) Communications/Marketing Subcommittee: **Beth Layton**, Chair; **Allison Howard**.
- 2) Education/training Subcommittee: Charlie Parker, Chair; **Cheryl Dee**, Nadine Dexter, Chuck McClure, **Kathleen Moeller**, and **Roxanna Tovrea**.
- 3) Content Subcommittee: Mark Flynn, Chair; **Linda Butson**, **Barbara Shearer**, **Kaye Robertson**, **Pat Clark**, **Beverly Shattuck**, **Sue Felber**, **Deborah Lawless**, and **Roumiana Katzarkov**.

Primary achievements in 2007-2008

- **Appointment to AHCA Work Groups**: FCHIN members **Kaye Robertson**, Director, Health Professions Division Library, Nova Southeastern University; **Pat Clark**, Library Director, All Children's Hospital; Mark Flynn, Director, Florida Electronic Library; Debra Fleming (not member of FCHIN but Webmaster for the Florida Electronic Library); and **Barbara Shearer**, Director, Maguire Medical Library, Florida State University College of Medicine were appointed to Agency for Health Care Administration (AHCA) FloridaHealthFinder.gov Work Groups. The website for the Public Relations Work Group is: (http://www.fdhc.state.fl.us/schs/chis/twg_pr.shtml)

- **The FSU College of Information's Information Institute**, contracted by the Florida Electronic Library to assess public library and school consumer information needs, concluded its study. The full report can be found at <http://www.flelibrary.org/about/FEL-Health-Services-Eval.pdf>

- **The Education/Training Subcommittee** working in conjunction with Florida's Multitype Library Cooperatives (MLCs) and the National Networks of Libraries of Medicine Southeastern Atlantic Region (NN/LM SEA) is sponsoring four web-based consumer health information workshops (see following list of

workshops) for Florida libraries in 2009. Librarians participating in the workshops will receive credit toward the Medical Library Association's (MLA) Consumer Health Information Specialization. Plans are underway with the NN/LM SEA to deliver a two-day "Training-the-trainer" seminar that will certify Florida librarian participants to teach the courses.

1. Beyond an Apple a Day: Providing Consumer Health Information at Your Library - This hands-on class provides an overview of core consumer health information resources, the reference interview, disclaimers, and privacy issues.

2. Prescription for Success: Consumer Health Information on the Internet - This introductory course includes the basics of MedlinePlus.gov, ClinicalTrials.gov and other resources from professional medical associations and advocacy groups including information on drugs and herbal remedies.

3. From Snake Oil to Penicillin: Evaluating Consumer Health Information on the Internet - This hands-on class helps participants learn to identify reliable consumer health resources on the Internet. It includes criteria for assessing the quality of health information websites.

4. Geeks Bearing Gifts: Unwrapping New Technology Trends - Participants will develop an increased awareness of new and changing technologies and how they affect library services. Topics include instant messaging, podcasting, blogs and wikis, social networking, collaboration software and more.

• **A poster presentation**, "Making Magic: Joining Forces to Create a Statewide Consumer Health Information Network" was developed by **Beth Layton, Linda Butson, Cheryl Dee** and **Barbara Shearer** and delivered at the Annual Meeting of the Southern Chapter of the Medical Library Association, Birmingham, AL, October 2008. • **The Content Subcommittee** is in communication with the Gale Company. Gale is considering revamping its Health & Wellness database for more effective functionality with the Florida Electronic Library.

• **The Florida Electronic Library (FEL)** is reviewing the needs assessment data and incorporating it into its 5-yr. plan. The advisory committee for the FEL is the Florida Network Council made up of 14 members appointed by the Secretary of State. The Council met on August 29, 2008, and set consumer health information delivery as one of the priorities in the 5-year strategic plan.

• **The University of South Florida** has received a grant working with public libraries in Lakeland and senior centers in Sarasota.

• **The University of Miami** has received a grant for a series of health fairs in surrounding areas that have minority populations.

• **The Florida State University College of Information and the College of Medicine** has applied for an NIH health literacy grant. The goal of this 18-month exploratory pilot project is to understand, promote, and increase health-information literacy for Florida public librarians and library staff members specific to the needs of elderly rural populations they serve.

To conclude, the NN/LM Express Planning Award that funds the FCHIN Steering Committee has been approved by Janice Kelly, Executive Director of the NN/LM SEA and ex-officio member of FCHIN, for extension to June 30, 2009. Funds remaining from the Award will be combined with the funding pledge by FHSLA to host a fifth face-to-face meeting of the FCHIN Steering Committee at the April 2009 Annual Meeting of FHSLA.

An Alternative to Journal Vendors – One Library's Experience

How to Go It Alone For Your Medical Journals An Alternative to the Journal Vendor in a Small Hospital Library

When I started my job as Medical Librarian at Shriners Hospital for Children in 1985 it seemed most appropriate to use a journal vendor. As a fairly new librarian I wanted to follow the norm and get support from one of the many competent journal vendors. Additionally, since I was starting the Shriners Hospital Library from scratch I felt their expertise and organization would make my job much easier. And it did, until journal price increases and service charges took their toll. So twenty years later, in 2005 I decided to take the leap and order journals on my own.

I began the process by organizing all my journals by publisher. I found that I had large quantities of journals that were from two major publishers. I contacted each of these and explained that I would be ordering on my own. I was able to receive a 25% discount from one publisher due to the quantity of the order. With some publishers I was able to order for three years at a time. Thus I saved on any yearly journal price increases. This in itself can be a huge savings.

I had about 100 journals in the library at the time I made the switch. Fifty percent were donated and another dozen or so I had simply ordered on my own. I had started a Family Library in 1994 and ordered several consumer magazines aimed at patients and their families. Titles such as Exceptional Parent, Sports n' Spokes and SpecialLiving Magazine were perfect for this library and inexpensive. At the time I couldn't see paying the service charge on these cheaper titles so I ordered them directly. Now, with ordering on my own things would actually be less confusing as all journals would be ordered directly. I became more in control of the entire ordering process.

Vendors were always able to assist in obtaining missing issues. But now that I am ordering directly I seem to have less missing issues. If I do miss an issue I grab a back copy off the shelf, call the customer service number listed inside and very quickly receive the errant issue.

I learned a great deal by attempting this change. I learned to negotiate and ask a lot of questions. I learned that I have to sometimes take no for an answer. Not every publisher is willing to give a discount. I learned to always be honest. The journal WILL be kept in the library and I AM a librarian. A few publishers, even knowing this, still let me order under my name and not have to pay the higher institutional rate. I learned how to be a little better organized. I learned that a bit of groundwork in the beginning of a project can sometimes reap great benefits – ultimately saving both time and money. It has been well worth it.

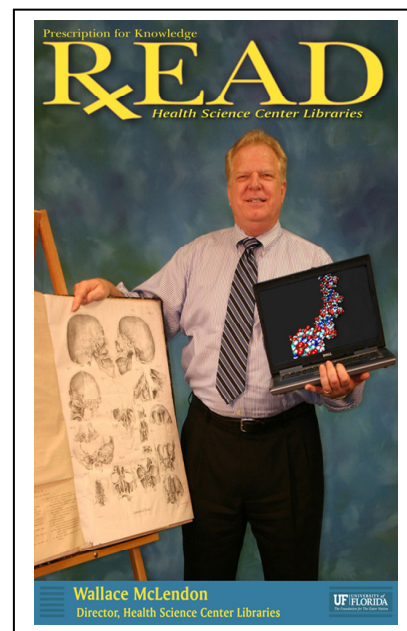
