FHSLA 2012 Annual Meeting: “Emerging Technologies in Medical Libraries”

Librarian/Paraprofessional Scholarship Essay

The FHSLA Librarian/Paraprofessional Scholarship enabled me to attend one of my first professional events in the medical library field. As a hospital library assistant, I am aware that the modern medical library must take on the role of a technological and information hub.

The continuing education course, taught by Ellie Bushhousen, was particularly intriguing. Cloud computing in its many forms represents a great opportunity for libraries to save money, provide better services, and increase collaboration. Nadine Dexter’s lecture on how to integrate technology within the modern medical library was fascinating. Her main point was that libraries must embrace mobile technology and reach students and staff where they are. This means providing information resources that will function on their chosen devices, particularly smart-phones and tablets. The wealth of resources she presented gave me some excellent starting places in planning additional outreach resources to mobile users of our library. I also appreciated the excellent discussion from the panelists and was impressed by the necessity of collaboration with the IT department and medical staff when undertaking a technology project with library resources.

One of the best parts of the conference was meeting the wide variety of librarians. I was surprised by the close connection and collegiality among such a diverse group of medical librarians from hospitals, universities, and medical centers. Learning how other medical libraries have dealt with various problems gave me ideas in improving my library. I appreciated the professional emphasis on continuing education and improving one’s skills with new technology. Visiting with the vendors and discussing new products provided a great learning experience. Attending the FHSLA meeting was a privilege and I look forward to collaborating with many of the people I met there.

One Hundred New Medical Students Receive iPads

This fall the Harriet F. Ginsburg Health Sciences Library continued its iPad initiative, now in its second year. New iPads were deployed to one hundred new first year medical students of the University of Central Florida's College of Medicine. Each student was personally greeted by library director, Nadine Dexter, who shared with them details about how the library's iPad initiative began in 2010 and about the library's two-year mobile technology study. The library once again was one of the most popular stops at the UCF COM orientation fair, featuring its famous popcorn machine and a stunning display of an iPad floating in water protected by a waterproof sheath.

Smartbooks for New Medical Students

This year the library embarked on an exciting partnership with interactive e-textbook producer, Inkling. The library is providing new first year medical students with nine of their required textbooks on the Inkling platform, including Thompson and Thompson Genetics in Medicine and Basic and Clinical Pharmacology, along with Bates Guides to Physical Examination and History Taking, which was highly popular with last year's M-1 students. Inkling e-textbooks, or "smartbooks" are changing the way students study by including varied modalities of learning. As opposed to a static print textbook, these interactive texts contain videos, sounds, spinning images, quizzes, and more. Students can read their textbooks on their iPads or smartphones using the Inkling app, or on the Inkling website. The library will be conducting a survey in December to gather student feedback and to determine whether the library will continue with this pilot project next year.

Appreciating Our Faculty

The Health Sciences Library has started a new tradition of showing its appreciation to College of Medicine faculty. Last August the library invited faculty to a casual, catered lunch where colleagues could mingle and relax before gearing up for the new semester. This year the library continued the tradition with a fun barbeque themed Faculty Appreciation Luncheon. Gingham tablecloths and bales of hay decorated the atrium in front of the library, where faculty lined up to feast on barbeque delights. This year's lunch was equally well attended and well received, ensuring a lasting annual fete.

New Name for Florida Hospital College of Health Sciences (FHCHS)

The Board of Trustees is pleased to announce that Florida Hospital College of Health Sciences (FHCHS) became Adventist University of Health Sciences, effective August 13, 2012.

The University will continue Florida Hospital College's commitment to healthcare as ministry and its legacy of excellence in education while still maintaining close ties to Florida Hospital and Adventist Health System. College President, David Greenlaw, stated, "We feel that the name Adventist University of Health Sciences is representative of the College's continued growth while still preserving our past. Our new name doesn't change who we are, it simply better defines us."

Earlier this year, FHCHS announced the planned addition of four new graduate programs: Master of Healthcare Administration, Physician Assistant, Doctorate of Nurse Anesthesia Practice, and Physical Therapy. In April 2012, the College broke ground on a new 90,000-square-foot addition to the campus that will house many of these graduate programs.

"With the physical and academic expansion on our campus, the time was right for this name change," said Greenlaw. "I couldn't be more pleased with the decision of the Board of Trustees."
