

2016 Annual Meeting Reports

The following reports are impressions of the April 7-8, 2016 FHSLA annual meeting by the student and librarian scholarship winners.

Report by Student Scholarship Winner Hannah Pollard

If you missed the 2016 FHSLA Annual Meeting, then I’m sorry to tell you that not only did you miss inspiring presentations and people, you also missed your chance to meet some furry friends as well – Golden Snitch, a golden retriever, greeted us at the reception in his official capacity as Ambassador to the Shimberg Health Sciences Library. Snitch embodied the friendly spirit of the meeting and set the tone for a conference that I feel lucky to have attended.

Both continuing education courses, the first on research and the second on how to effectively use grey literature, were topics that I had never really encountered in a formal way before. The presenters offered both tangible support in the form of resources as well as emotional support to encourage everyone that yes, these are things that you can do! There were also poster presentations and other lectures that allowed the diverse attendees to demonstrate their knowledge in a variety of subjects. I have never seen such a dynamic combination of passion and expertise, and I learned about everything from text mining to organizing community partners to cyber security to starting special libraries from

scratch. Days later, I'm still coming up with new insights from the conference and trying to find ways to incorporate everything I learned into my career as a student.

To those that I met, I can't express how much being able to speak with you impacted my journey moving forward. To those that I didn't have the chance to meet, I hope to come back to future meetings not a student but a full member – and I can't wait to see you there.

Report by Student Scholarship Winner Carrie Cullen

The true value of any professional conference comes down to the people. The commitment and passion that Florida Health Science Library Association members have for their profession is evident, and I express my heartfelt gratitude to them for making my first health sciences librarianship conference such a cohesive and memorable experience.

As a new MLIS student and aspiring medical librarian, I was pleased to attend both of the MLA continuing education courses offered at this year's meeting, particularly since the two courses complemented each other perfectly. During the first course, "Planning, Conducting & Publishing Research," Nancy Allee of the Taubman Health Sciences Library spurred me to consider ways I could contribute worthwhile research to the field, even while still completing my studies. My mind still dancing with possible research ideas, I attended the course on grey literature led by Gaelen Adam of Brown University's Center for Evidence-based Medicine the following morning. She spoke of many ways to explore largely untapped information resources, introducing me to an exciting means by which to engage in future research. One finding, a significant publication bias toward positive results, is particularly disturbing, though perhaps not surprising. Clearly, ignoring the biomedical grey literature is not an option.

Later, the University of South Florida's Steven Walczak demonstrated his Scale of Theoretical and Applied Research (STAR), which employs concept mining as a tool for effectively classifying journal articles. Steve Gary of the University of South Florida rounded out the program, addressing the extent of the growing cyber security threat faced by the health information industry.

Speaking with health sciences librarians from across the state and hearing firsthand about the work they do was immensely valuable. I eagerly anticipate next year's meeting, though I expect to reconnect with other members long before then. I sincerely wish to thank FHSLA for awarding me the scholarship to attend this meeting, as well as all of you who so warmly welcomed me into your professional community. I look forward to being an active member of your organization for many years to come.





Orlando Health Library Services Orlando Health Orlando, FL

The Graese Community Health Library, under the auspices of the Health Sciences Library at Orlando Health, was awarded an Express Outreach Project Award by the National Network of Libraries of Medicine. Our outreach project is in partnership with Hispanic Health Initiatives, a local non-profit organization that aims to educate and advocate for medically underserved populations in Central



Florida. The award covered the purchase of 7 iPads, as well as training sessions in the use of reliable online medical information sources. Our medical librarians have bookmarked the best health information websites and apps on the iPads and are training the community health workers who volunteer with Hispanic Health Initiatives on using these resources. The training and resources are both in English and in Spanish. These volunteer community health workers go out to health fairs and events and meet with clients in need of health information and services. They use the iPads to help clients research health information, view videos, locate services and other health-related information as needed. This project is ongoing and we have had two training sessions for 15 community health workers so far. This project is helping provide appropriate health information out in the community at the point of need.

Also, per our signed agreement for accepting the award, all documents and publicity relating to this award must include the statement:

“This project has been funded in whole or in part with Federal funds from the National Library of Medicine, National Institutes of Health, Department of Health and Human Services, under Contract No. HHS-N-276-2011-00004-C with the University of Maryland Baltimore.”

The Health Sciences Library has refurbished its computer lab – turning it into space as a teaching classroom. We have added more computers and can now hold computer classes in the library.

In addition, the Health Sciences Library recently went live with an upgraded website and WorldCat Discovery Service. The migration allowed them to implement the WorldCat Discovery search box and transition from LibGuides version 1.0 to LibGuides version 2.0. The upgraded site includes a new search box, guides, image gallery, library announcements banner, classes and faster access to many library resources. Linda Knorr, Corporate Director, Learning & Development at Orlando Health

exclaimed, “[M]any team members are going to appreciate...this new website!!” The new site can be viewed [here](#) (certain links require remote access login).

All five of our faculty librarians attended the Medical Library Association annual meeting in Toronto, Canada from May 13-18, 2016.

Shalu Gillum and Natasha Williams presented a poster entitled, "Medical Librarians' Role in Clinician Recruiting in the Information Age." The poster described librarians' collaboration with the College of Medicine Department of Internal Medicine and COM HR Department to determine where best to recruit clinicians for an academic medical center and involved some interesting Google searches.

Deedra Walton, Head of Electronic Resources, and Shalu Gillum presented a paper presentation on behalf of the library faculty titled "Librarians as Part of the Big Picture: Collaborating with Faculty and Instructional Designers to Create a Rubric for Students on How to Use Evidence-Based Medicine Resources." The presentation explained the process our team

developed with the Practice of Medicine faculty to evaluate first-year medical students on their use of evidence-based medicine library resources to answer clinical questions during their patient encounters.

Pamela Herring, Electronic Resources Librarian, presented a poster titled "Developing a Replicable Methodology for Automated Identification of Emerging Technologies in Health Care", on which she collaborated with a team of librarians from other institutions as part of the Emerging Technologies Team for MLA. The poster described a systematic review-type process the team used to create a simple way for librarians to search PubMed for emerging technologies related to health and medical libraries.

Librarians at Commencement

This May the University of Central Florida College of Medicine graduated its last founding class. The Class of 2016, with 100 students, was the last class to begin at UCF COM before we welcomed our first “full” class of 120 students in 2013. Shalu Gillum, Head of Public Services, and Natasha Williams, User Services Librarian, participated in the commencement ceremony by walking with fellow COM faculty. UCF President John C. AAHSL New Directors Symposium Wraps Up

The Association of Academic Health Sciences Libraries (AAHSL) New Directors Symposium, which ran from November 2015 through May 2016, wrapped up at the Medical Library Association annual meeting in Toronto, Canada. Nadine Dexter, a member of the planning committee for the symposium, participated in the sessions, which began in Baltimore, Maryland last November, and ended at MLA with talks on budget, the life of a director, and how to staff the library.

Paving the Way for Librarian Promotion

This April Shalu Gillum, Head of Public Services, became the first medical librarian at UCF COM to be successfully promoted. Prior to Shalu’s journey through the promotion process, there was no path for medical librarians to advance to the next rank. The Health Sciences Library team worked closely with the COM Faculty Development team, Department of Medical Education, Dr. Richard Peppler, Associate Dean for Faculty and Academic Affairs, and the UCF Office of Faculty Excellence, to create and refine guidelines for medical librarian promotion, which had to be approved at the departmental, college, university, and Provost levels. The new guidelines, which closely mirror existing guidelines for medical education faculty, also take into account the unique ways librarians contribute to teaching, research and scholarship, professional service, and library service. Shalu was hired in 2010 at the rank of Instructor, and her new rank of Assistant Librarian will be effective August 2016.



The poster was titled *The creation of a college of nursing, health sciences library collaboration* by Allison Edmonds-Poff, PhD, ARNP, FNP-BC, Kathi S. The poster presentation described an experience in an academic health sciences center where a collaboration need was identified and a process established in order to facilitate communication between a college of Nursing and a health sciences library. Library Spotlight: Virtual Tour of the Louis Calder Memorial Library

Welcome to the Louis Calder Memorial Library!



The Calder Library was established in 1972. Today it serves the educational, patient care, and research needs of students, faculty, staff, residents, and other healthcare providers at the University of Miami Miller School of Medicine and the UHealth System. This System includes the University of Miami Hospital, Sylvester Comprehensive Cancer Center, Bascom Palmer Eye Clinic & Anne Bates Leach Hospital, and clinics. Calder Library staff also serve the Jackson Health System and associated clinics.

CALDER LIBRARY SERVICES

The Library's faculty and staff are dedicated to supporting its medical students, residents, faculty, and staff in their quest for excellence in medical scholarship, research, and patient care. Calder personnel strive to create continuous opportunities for learning, research, collaboration, and quality health care services for all of the University of Miami Miller School of Medicine, UHealth, and Jackson Health Systems.



Access Services

The Calder Access Services/Information Desk is staffed 102.5 hours per week. In addition to assisting patrons with a variety of questions, five well-trained, full-time staff are skilled at directing library users to the staff member or Library department best able to assist them. This staff manages the Library's 3-D printing service, the print reserve collection, and serves as Library Liaisons for reporting IT and all facility issues to the responsible campus departments.



Reference & Education



Four Reference and Education librarians participate in multiple professional and educational activities throughout the year. They teach MD, MD/MPH, MPH, and PhD students in medical school curriculum courses, and are

instructors in the Residents' Scholarly Activity Program (RSAP). The reference librarians participate in the Personal Librarian Program, which links first-year medical students to a designated librarian throughout the student's four years of Medical School. Attendance at the Systematic Review Workshop at the University of Pittsburgh Falk Health Sciences Library increased Calder librarians' skills at collaborating with researchers on Systematic Reviews and Meta-Analyses. The librarians serve on Medical School committees and the Nursing Research and Evidence-based Practice Council at the Sylvester Comprehensive Cancer Center. They also provide reference services at the University of Miami

Hospital branch library 20 hours per week. As part of community service, reference librarians participate in the University's Department of Community Service (DOCS) Health Fairs to introduce MedlinePlus and other consumer health information to health fair patients and provide on-site reference services for participating clinicians and medical students.

Technical Services & Interlibrary Loan

The small staff whose responsibilities are cataloging, processing, ordering print materials and journal subscriptions, updating records, and Interlibrary Loan (ILL) are all dedicated, mostly long-term employees.



They are committed to the Library's mission and over the years have developed a reputation among medical libraries for excellent ILL turnaround times. This resulted from cross-training, determination, and a competitive spirit that remains constant even as Technical Services positions have been reduced.

Biomedical Communications (Biomed Comm)



The Library's graphic arts, poster printing, and photography services department remains one of the most popular and well-used resources on the medical campus. Biomedical Communications (BC) generates its own revenue for operations, so it is a total cost-recovery enterprise. Consisting of two photographers/videographers and two graphic artists, BC's services are used by departments on all University of Miami campuses. The BC

staff provides professional graphics, imaging, and finishing services. From posters for scholarly research results to studio, event, and medical photography, the Biomedical Communications Department is the primary media and visual communication resource for Medical campus faculty, staff, and students.

Administration

The Administration staff at Calder Library includes the Interim Director, Deputy Director, Associate Director for Finance/Access Services/Biomedical Communications; the Associate Director for Digital Access/Interlibrary Loan, the Webmaster, and the Library's Administrative Assistant. During the past year, Calder administration was involved with LCME self-study meetings and reports, new building planning, and major collaborative projects with the other UM libraries. Merging of the Medical, Law, and Richter general academic library catalogs and migration to the Ex Libris ILS and Discovery were chief among these collaborations. A major removal of print journals and a print book deselection project will get underway this summer.



CALDER LIBRARY FACILITIES


Calder Library is located close to Downtown Miami in the Miami Civic Center/Health District area, where it shares a campus with Jackson Memorial Hospital, Miami-Dade County's public hospital and primary teaching hospital for the Miller School of Medicine. The Calder Library building is a four-floor



facility with computer and quiet study areas, group study rooms, a Mac Lab, an electronic classroom, a resting area with reclining chairs and a lounge where students can sit and chat. A “Collaboratory” serves as both a formal and informal meeting space and the History of Medicine room provides a more traditional area for quiet study and, occasionally, for School of Medicine social events. The Biomedical Communications Department is located on the lower level of the building along with IT owned training rooms. The Library shares its lobby with a Starbucks coffee shop which provides the much-needed Cup-of-Joe in the early morning and throughout the day!


First Floor Computer Area

The library updated all the workstations on the first floor in June 2015. Twenty new computers were added, including five new Macs, bringing the total number of workstations on the first floor to 80. Each workstation includes desktop power sources for portable devices. The area also has a round table for group work and height adjustable tables for patrons who prefer standing while they work.



3D Printing

3D printing requests are handled by the Access Services Department. Patrons may email their files directly to Access Services personnel for production of quality 3D products.



IT Help Desk Support



In early 2016, Calder Library and the University’s IT Academic Support Services partnered to provide onsite technical support for medical students. The Help Desk office, located in close proximity to the Library’s first-floor computers, is open Monday to Friday from 9am- 5pm, and now includes desktop support for the Library’s public computers.

Collaboratory



The “Collab” is one of the library’s collaboration spaces. This glass-sealed room is used primarily as a study space for group sessions but can be reserved for classes, workshops, and meetings. Twin monitors are connected to a computer for presentations and online learning, and whiteboards



are available for enhanced medical student studying.



Patron Lounge

This newly renovated area provides patrons with a place to meet up with friends, relax, and watch some television, or for studying.

SECOND FLOOR AREAS

The second floor is currently home to the Library’s bound journal collection. These bound volumes will be removed during the next few months to make way for a proposed makerspace, which will include a relocated Biomedical Communications Department, now housed in the Library’s basement. The second floor also features another computer area--the Library’s Mac Lab, a Relaxation room for weary students and residents, two private study rooms, and various other study areas. Library Administration offices are also located on the second floor.



Study Areas

The second floor has a multitude of study areas for patrons around the stacks.





Private Study rooms

There are two study rooms available, on a first come, first served basis.

Mac Lab

This previous study room was converted into a Mac computer lab for patrons who prefer to use Apple computers. The addition of these Macs completed the Library's goal of making Apple computers available on all Calder Library floors.



Relaxation Room

One of the unique features of Calder is the Relaxation Room. Equipped with fully reclining Relax-The-Back and massage chairs, the room is a dark, quiet, relaxing space where some of Calder's most weary patrons take naps after long bouts of studying, taking tough exams, and enduring grueling hospital rotations.



THIRD FLOOR AREAS



The top floor of the library is the designated "quiet floor," used mostly for study. The third floor houses the regular collection of books, as well as Calder's extensive History of Medicine Collection located in a dedicated room. The Library's electronic classroom is also located on this floor and is used for an array of classes, workshops, training sessions, and exams throughout the year.


History of Medicine Room

The History of Medicine (HOM) Collection housed in this room dates back as far as the late 1800's. One of the largest rooms in the library, it is used mostly as a study and lounge area. The HOM room is used for events and special functions with permission of Library Administration. Some Mac computers are available for use in this room.



3rd Floor Classroom

The Library's Electronic Classroom is used extensively by various departments on campus for classes, day-long board exams, HR orientations, and other activities. Room rental is affordably priced for University Departments and is free for student related activities. It has 32 computer terminals, one instructor/presenter computer and is equipped with 2 projectors for viewing presentations. The classroom's computers are available for use by Library patrons when no classes or other activities are scheduled.



BASEMENT



The Calder Library Basement level is another cool feature of the building. Not many buildings in Florida have functional basements! Calder's lower level houses the Medical Campus' Biomedical Communications Department. A recent addition to this level is the UChart Training Rooms. UChart is the University of Miami Health System's Epic electronic medical record brand. These training rooms are dedicated to training all faculty, staff, and residents who use the health system's electronic medical records on a daily basis.
