It is a credit to our profession that we continue to innovate and find ways to provide services to our patrons under less-than-ideal conditions. Inside this edition of the newsletter you'll read examples of librarians using mobile devices to utilize electronic resources and FHSLA members flexing their intellectual muscle at meetings and conferences around the state and country. One member is working in medical informatics, a field that is assuming a more prominent role in healthcare settings. In short, here are examples of medical librarians contributing to healthcare information right along with faculty, students and other professionals.
